2. NEIGHBORHOOD WATCH

Brandy Swain from the Rural Crime Prevention, who can be reached at (805) 781-4578, presented a slide show presentation on information pertaining to problems and concerns of rural area Neighborhood watch. Ed Bryant is the Deputy Sheriff for the area.

Issues covered by the slide show presentation included:

- 1. Animal Cruelty If one was to have a concern about an animal being neglected they are to call the Sheriff to have them handle the situation.
- 2. Dog's & Livestock Owner is responsible for keeping dog's fenced and contained in property. Owner is responsible for 3 times the amount of the livestock if dog damages livestock. Ag Code permits the act of shooting a dog if in act of attacking livestock.
- 3. Cock Fighting Watch for altercations of the birds.
- 4. Illegal Dumping Grants are available for reimbursement of dumping on land other than private property.
- 5. Trespassing Always lock cars and do not leave valuables in plain sight.
- 6. Farm Equipment Theft Always take keys with you and lock up as much as possible.
- 7. OAN Program Sheriff Office stamps equipment with and owner number witch will give a business or ranch name along with a number, address, and name. Program is free. For more information on this program go to www.agcrime.net
